Schedule: League begins Wednesday May 7th, 2025, bowls 14 weeks, ending Wednesday, August

6th, 2025. Practice will start at 7:45 pm and league play will begin at 7:55 pm.

Team Roster/CAP: This league is a 3-member league.

All teams must fit under the 630 average cap. The averages are based on the NFL average of 2023 – 2024 of 24 games or more on BOWL.com.

If they did not bowl in NFL last year, we will take the most recent NFL average, up to 5 years.

If there is no NFL average, we will take a 2-year composite from all leagues over 21 games excluding sport/challenge leagues.

Bowling Fees: The weekly fee to be paid by each member, each week, is \$25.00 and the fee

breakdown is as follows:

Weekly Bowling Fee/banking/secretary \$17.25

Prize Fund \$7.75

The last two weeks of bowling shall be paid by the 5th week of bowling. Bowlers may not be more than 2 weeks in arrears. A bowler must give two weeks' notice if they must quit the league.

Sanction: This league is sanctioned by USBC. If you are already sanctioned for this league season, all you must do is fill out a sanction card.

If you are not sanctioned by USBC for this season, you have 2 payment options.

\$10 sanction: This will get you an average with USBC but no awards (recommended)

\$30 sanction: This will give you an average and awards for your bowling.

ALL sanctions end in August, so this sanction is only good for 2 months. Everyone will have to renew their USBC membership in September.

Averages: Averages will be established the first night of bowling no matter number of games and

the line-ups will change accordingly each week.

Legal Lineup: The line up must be in order of lowest average to highest average. 1st bowler is the

lowest average, 3rd bowler is the highest average. A legal line up shall consist of 1

bowler and must be present by the end of the 3rd frame of any game. A vacancy bowler does not count towards a legal line up. Late bowlers may enter a game provided 3 frames have not been completed.

Substitutes: Substitutes will be allowed; however, no subs are permitted on position round. Subs must have their average verified by the house before they bowl.

Vacancy Score: The vacancy score will be 170 per game. In the event of a vacant team, the team bowling against the vacant team must bowl within 30 pins of their team average to receive the win for that game. A new team filling the vacant team spot will take over any wins the vacant team earned.

Forfeit:

In the event of a forfeit, the team present must bowl their average minus 30 pins to receive a win for that game. Points not won for failing to bowl the minimum score will not be credited for the team that forfeited.

Position Rounds: Week 14, August 6, 2025 will be the only position round. Only rostered bowlers are allowed to bowl position round. All makeups are due before position round. Only prebowls are allowed.

Standing Points: Peterson Point system will be used

1 point for beating your opponent

3 points for a team win – for a total of 6 points per game

A total of 30 points can be a won a night – 4 games and series

Any ties will be given ½ point.

Absent Bowlers & Points: If you are bowling an absent bowler, you must beat their average to gain a point, if you do not beat their average, they will win the point.

If both players are absent, the team who wins the game will win that individual point.

Pre-Bowls/Make-Up: Pre-bowls and make-ups are permitted and must be scheduled in advance with the bowling center. All make-ups must be completed within 2 weeks for their regularly scheduled date. All pre-bowls and make-ups must be completed prior to position rounds. Only pre-bowls are permitted on position round.

Prize Money: We are paying Team Standings Only! We will have a prize fund released by week 7.
