

Justice By-Laws 2025 – 2026 Season

Schedule: The league begins Monday September 8, 2025, and ends Monday April 20, 2026. We will bowl 32 weeks, taking 1 week off between Christmas and New Years on December 29, 2025. Practice will start at 6:15 pm and league play will begin at 6:30 pm. We will bowl 3 games each week.

Sanction: This is a USBC sanctioned league. All bowlers, including substitutes, must be sanctioned. The sanction fee for the 2025-2026 season is \$30.00.

Team Roster: 5 bowlers per team. There is no gender requirement in this league.

Bowling Fees: The Team is required to pay \$100 each week.

The weekly fee to be paid by each member, each week is \$20.00, and the fee breakdown is as follows:

Weekly Lineage	\$16.50
Prize Fund	\$ 2.75
Secretary/House Banking	\$ 0.75

The team will owe the entire \$100 each night whether there is a vacant or missing bowler.

There will be an extra \$40 per person, \$20 each half, that must be paid and go directly to the prize fund. It is to be marked under weeks 33 and 34 in the pay envelope.

Weeks 31, 32, 33 & 34 of bowling shall be paid for by the 7th week of bowling.

Bowlers may not be more than 4 weeks behind in payment or they will not be allowed to bowl, and the team will use their average. The bowler will still owe for those weeks.

Bowler Drop: A bowler must give two weeks' notice if they must quit the league. They will owe for those 2 weeks. There is a form they must fill out for Arapahoe Bowl records.

This is a **guaranteed league** for all weeks.

You may pay by cash, check (make out to ABC), Debit Card at the Front Counter or Credit Card at arapahoebowl.com/justice (processing fee does apply)

50/50 Pot: We will be selling 50/50 tickets each night. The money made from the Pot will be evenly added to the prize fund at the end of the year to each bowler in the league.

Averages: Averages will be established the first night of bowling, regardless of the number of games bowled.

Handicap: Handicap shall be 90% of the difference between individual's average and 220. Handicap will be computed after the first night of bowling and applied to the games bowled that night.

Legal Lineup: A legal line up shall consist of 2 bowlers (2 regular members or 1 regular member and 1 substitute) and must be present by the end of the 3rd frame of any game. A vacancy bowler does not count towards a legal line up. Late bowlers may enter a game provided 3 frames have not been completed.

Substitutes: Substitutes will be allowed. It is up to the team if the sub pays, or the actual member of the team pays for that night's bowling fees.

Vacancy Score: The vacancy score will be 140 per game, with a 72 handicap. In the event of a vacant team, the team bowling must bowl their average minus 50 pins as a team, to receive a win for that game. The team with the vacancy will be responsible for paying for the vacant spot until the vacancy spot is filled.

Forfeit: In the event of a forfeit, the opposing team must bowl within 50 pins of the team's average to win points.

Position Rounds: There will be 2 position rounds.

1st position round is December 22, 2025 – subs must have a minimum of 12 games bowled to be eligible to bowl this position round.

2nd position round is April 20, 2026 – subs must have a minimum of 24 games bowled to be eligible to bowl this position round.

Standing Points: The following points will be awarded each week, for a total of 5 points:

1 Points for each handicap game won.

2 Point for team handicap series won.

Recaps: This league does not use recaps. Therefore, it is your team responsibility to notify the counter of new league members, substitutes, name corrections, team name changes, line-up change and any additional information that would normally be communicated via the recap.

Standing Sheet: Each week the league standing sheet will be posted to ArapahoeBowl.com and LeagueSecretary.com. There will be 1 league standing sheet at the Front Counter each week. Otherwise, you can go to either website to look at the league standing sheet. You can sign up for the email list at arapahoeBowl.com/email to get notified when the league standing sheet is updated each week.

Pre-Bowls/Make-Up: Pre-bowls and make-ups are permitted and must be scheduled in advance with the bowling center. You may pre-bowl for any week. All make-ups must be completed within 2 weeks of their regularly scheduled date. All make-ups must be completed prior to the position rounds. The position round may only be pre-bowled.

All Pre-Bowls and Make-Ups must be bowled as a team. If a team bowls without a member, that member cannot bowl that league night and cannot do an individual pre-bowl or make up. The team will use that bowlers average. That bowler is still required to pay the bowling fees.

Tiebreakers: In the event of a tie for team standings, total pins with handicap will determine positioning.

Prize Fund: This league only pays Team Standings at the completion of the season. There is no payment for Team Game or Series Awards, High Average, Most Improved Average or Individual Game or Series Awards.
